5-30 P.M.: Business Session to adopt the following Resolutions

ITEM NO.1: TO CONSIDER AND PASS THE AUDITED ACCOUNTS OF THE ASSOCIATION FOR THE YEAR ENDING ON 31ST MARCH, 2013

On a proposal being made by Shri Abhijit Sarmah and seconded by Shri J.N. Goswami the Audited Accounts of the Association for the year ending on 31st March,013 is adopted unanimously by all Members.

Tea Board plan to sustain brew fame

Jorhat, June 30: The Tea Board of India is about to enforce production and labour management regulations in the industry to sustain the popularity the beverage, especially the Assam and Darjeeling varieties, enjoys across the world.

Disclosing this, Tea Board of India chairman M.G.V.K. Bhanu said strict regulations were the need of the hour to maintain sustainability so that Indian tea continued to be the world's favourite.

Bhanu said Assam tea was so popular across the world that even villages in Germany, Russia and Kazakhstan knew about it along with the names of the producing gardens. To maintain this track record, the industry must maintain quality of the tea, he added.

"These villages probably have no idea where Assam is but they know this part of the world produces the best quality tea," Bhanu said at Jorhat Gymkhana Club here last evening, while addressing the 76th annual general meeting of Assam Tea Planters Association, the oldest tea association in Assam.

"I am sorry to say that the most gardens are not concentrating on producing quality tea and if this trend continues, it will be difficult for Indian tea to remain the preferred beverage in this competitive world. There will be strict regulations coming up soon to maintain quality and other aspects in tea production."

Industry sources said the new set of rules would come into force after the July 11 release of the sustainability code for tea — a joint initiative of the Tea Board and certification bodies such as the Rainforest Alliance, the Sustainable Trade Initiative (IDH) and Hindustan Unilever Ltd.

The Tea Board chairman said many gardens were not maintaining the quality of leaf, which was directly proportional to prices. "Better quality leaf is very essential to produce quality tea that will fetch good prices. Planters should ensure that they maintain the minimum residual content in the tea and should be careful while using chemical fertilisers and pesticides."

Bhanu said he had interacted with tea buyers in a meeting at Vadodara recently where he was made to understand that there was always great demand for quality tea.

He said the labour force was an important stakeholder in the tea industry and all possible steps should be taken for its welfare. "The industry can no longer treat the labour force as they did a hundred years ago and all necessary steps should be taken for their welfare," he said.

Bhanu said many gardens had not appointed a permanent labour welfare officer, who could act as a friend, philosopher and guide for the labourers and deal with their problems directly. "Gardens not having full time labour welfare officers would be penalised as soon as the new set of rules are enforced," he said.

The Tea Board, he said had been taking special measures for the welfare of the workforce and Rs 25 crore had been earmarked for the welfare of labourers in the tea industry in the Twelfth Plan period. "There will be more funds for labour welfare in future."

Bhanu said the board had been taking special interest in the development of the small tea growers sector as it contributed nearly 30 per cent of the total production. "Planters should provide all necessary help and support to the small tea growers as they make a big contribution to the industry."

Speaking as the chief guest, DoNER minister Paban Singh Ghatowar said Indian tea had been lagging behind in terms of research and development. "The Tocklai Experimental Station has not been able to meet the aspirations of the industry. Though it has come up with a few tea clones, there wasn't any path-breaking achievement by Tocklai."

The association's chairman, Rajib Barooah, said promoting tea through tourism was an important thrust area through which Assam tea could develop on the lines of the Nilgiris, where tea and tourism are the two pillars of the economy.

Stating that air connectivity was very important for the landlocked region, as it was a safe mode of transport to bring in tourists and businessmen, Barooh said, "I take the opportunity to request the state government to allot a suitable plot of land for a new airport at Jorhat, which will go a long way in development of the region."

He said Jorhat, the erstwhile capital of the Ahoms and the tea capital of Assam, could also be called a tourism hub of Assam, given its proximity to Kaziranga, Majuli, Sivasagar, Arunachal Pradesh and Nagaland.

Call to include tea in priority sector

JORHAT, June 30 – The Assam Tea Planters Association (ATPA) has requested the Centre and State Government to bring tea industry into the priority sector of the Petroleum and "other related ministries" for supplying adequate fuel for running their factories which have suffered from "dismal power supply" in the State.

Addressing the 76th annual general meeting of ATPA here on Saturday evening, chairman of the association Rajib Barooah said the supply of gas has been inadequate and extremely irregular with very low pressure since 2011, compelling them to close down the factories temporarily.

"Erratic power supply is one of the factors for increasing cost and quality deterioration at the manufacturing stage and thus deserves some major attention from the authorities concerned," Barooah said at the meeting, which was also attended by DoNER Minister Paban Singh Ghatowar and Tea Board Chairman MGVK Bhanu.

Besides highlighting many other general issues of the tea planters, the ATPA requested Ghatowar to take the initiative to develop an integrated tea park and set up a tea auction centre in Jorhat.

They also need satellite warehousing facilities in Golaghat, Jorhat, Sivasagar, Dibrugarh and Tinsukia districts which produce about 400 million kg of tea annually out of the total 580 million kg produced in the state.

The DoNER Minister said that he would discuss the issues with his colleagues in theministries concerned. Stressing the need for new innovations for ensuring quality teaproduction in the State, the Minister said that Toklai Tea Experimental Station's performance in this case "is not up-to-the mark".

He also said that the planters should give adequate importance to the tea workers in their respective tea estates as the living standard of thousands of workers was yet to improve.

Tea Board Chairperson MGVK Vanu asked the tea garden owners to recruit welfare officers in their gardens within six months. "I am slightly upset after knowing that there are no welfare officers in many tea gardens in the state. Recruit the welfare officer within six months. It is mandatory," Bhanu said.
