A meeting for discussion on the recently issued Notification regarding Provincialisation of Tea Garden Managed Schools held on 02/05/2023 at 10.00 AM in the Conference Hall of Hon'ble Minister of Education, Assam, Block-B, Janata Bhawan, Dispur under the Chairmanship of Hon'ble Minister of Education, Assam.

Members present at ANNEXURE - A.

At the outset, Hon'ble Minister of Education, Assam welcomed all the members present and briefly stated the objectives of the meeting. All members present in the meeting put forward their valuable suggestions and views. After a threadbare discussion the following resolutions were adopted:

- 1. Govt. haS issued Notification regarding Provincialisation of 419 Tea Garden Managed Schools and sanctioned creation of 838 teachers posts maintaining the PTR norms of 30:1 in LPS and 03 teachers in 01 TGMS UPS. If after verification, it is found that there is requirement of more teachers in any school, additional teacher is to be provided.
- 2. Teachers who were appointed by the Tea Garden Management and are working in the schools shall not be disturbed by Tea Garden Management till the age of attainment of superannuation. In this regard ACMS shall make an agreement with Consultative Committee of Tea Planters Association (CCPA). A copy of the agreement is to be submitted to the Labour Welfare Department, Assam and the same shall be notified by the Department. A meeting in this connection is to be convened at an early date.
- 3. Appointment of Teachers shall be made as per existing Rules. However, teachers of Tea Garden Communities may be prioritized and accommodated.
- 4. Infrastructure of the Tea Garden Managed Schools shall be looked after by the State Government. Special proposal is to be furnished for infrastructure development of these schools
- 5. .SSA will be responsible for providing MDM, FTB, Uniform as well as other grants to the Tea Garden Managed Schools. The matter of consideration for regular appointment of the Tea Garden Management appointee teachers having requisite NCTE norms in accordance with the Govt. recruitment process will be taken up by Govt. in phases and will be brought to the notice of Hon'ble Chief Minister, Assam.
- 6. The formation of School Management Committee (SMC) is to be reviewed and initiative is to be taken for constitution of SMC as per guidelines in the Tea Garden Managed Schools. The matter of SMC formation as well as training of the teachers appointed by Tea Garden Management are to be taken up by Department of School Education.
- 7. The responsibility of taking necessary action for providing a respectable salary and upholding the dignity of the existing teachers appointed by the Tea Garden Management shall be upon the ACKS/ACMS/ABITA/TAI/NETA etc.
- 8. All shall work together for development of education in the provincialized
