The meeting was chaired under the Chairmanship of Sri Pranab kr. Bora, ACS, District Development, Jorhat. The General Manager, DI&CC, Jorhat, Assistant Director, Tea Board Jorhat were present alongwith representatives of NETA & Small Tea Growers Association.

At the outset, the Chairman welcomed all the members present and requested the Assistant Director, Tea Board to brief about the occasion of the meeting. The Chairman expresses his displeasure on absence of other representatives of respective Tea Association and requested the member from Tea Board to ensure the presence of all the tea associations in next meeting.

After a thread bearing discussion, the following decisions have been taken:

- The Chairman directed the Tea Board to complete the awareness programme on Green Tea Leaf fine leaf counting mechanism among all the manufacturing units, leaf collector and growers at an early date and also requested the tea associations to extend their full cooperation towards successful conduct of the programme.
- 2. The Chairman directed all the manufacturing units to complete the process of NOC by 30/6/2023 as from 1/7/2023, NOC is made mandatory for all vehicles carrying green leaf.
- 3. The Chairman intimated that the minimum price of green leaf should not be lower than Rs.25.00 for the month of June, 2023 and requested all the tea manufacturing units of Jorhat district for strict compliance of the same.
- The Chairman informed the house that the first meeting of District Level Monitoring & Inspection Committee will be held in third week of June 2023.

Towards the end of the meeting, the Chairman requested Tea Board to ask the manufacturing units to deposit their contribution towards DC's Development Fund by July 2023 who have not deposited yet.

The meeting ended with a vote of thanks from the chair.
