Sub : Advisory for Payment of Minimum Benchmark Price (MBP) by manufacturers directly to the bank account of small growers from whom green leaf is procured

Dear Sir,

Directed to state that Consequent upon the notification of demonetization by Government of India vide SO 3408(E), dated 08.11.2016, request was made to all Producers Associations for direct transfer of wages to bank accounts of the individual workers.

The objectives of Direct Benefit Transfer (DBT) and the migration to a digital payment system for setting up a cashless economy are also being pursued by the Tea Board.

It is requested that all manufacturers outsourcing green leaf from the small tea growers may remit the monthly Minimum Benchmark Price notified by the Tea Board, directly to the bank account of the small tea growers, for ensuring a digital payment system and a cashless economy and also for establishing better coordination between the manufacturers and the supplier small tea growers.
